

## **VPD - VIEW PUBLIC DOCUMENT-Developed**

Any logged in user can view the documents of any LLP by giving the LLP Name or LLP Number (through search mechanism).

Forms 2, 4, 8 & 11 (excluding addendum in 4 & 11) are the documents 'OPEN' for public viewing. The users will be able to 'View' the Form filed in 'html' format only (for both html forms and PDF forms). Attachments will be opened in the format of the file being attached and the same can be saved.

VPD is value added service of the LLP System and is a paid service. Users would have to pay Rs.50 per LLP.

For Example, if a user selects 'Four' (4) LLPs, he/she is supposed to pay Rs.200/- On payment, an SRN is generated and the same is viewable in the 'user dash board'. Upon clicking the link 'View Public Document' in the 'user dash board' area, the timer starts (every SRN generated in the VPD is valid for a period of 3 hours and 7 days whichever finishes early). The session time is maintained at 30 minutes. If the 'user' closes the window without proper 'logout', he/she would lose a maximum of 30 minutes of time.

User cannot 'Save' or 'Print' the document. The 'Right Click' option is also disabled.

Session management is handled in a way to allow only one model window to be opened under VPD for a particular user at any given point in time. Until the user closes the model window in one browser or system, he/she cannot open the same in another browser/system. If the user browses through the selected documents of the LLPs and logs out properly, then only the time used to browse the documents in VPD would be deducted out of the 3 hours allocated for VPD of documents for a particular SRN.

### **Requirement**

- Once logged in user clicks on VPD, user is asked to fill in the LLPIN / FLLPIN and / or LLP name.
- The user can view all documents (Forms 2, 4, 8 & 11) pertaining to the LLP/FLLP selected on making payment. The user will be able to add documents pertaining to the selected LLP/FLLP to the cart.
- VPD is a paid service. Rs.50/- per LLP selected. User clicks on Make payment Button where user has two options to make payment either by credit card or by e-banking.
- After successful payment, user is applicable to render the services for 3 hours in 7 days.
- The printing option and save and/ or save as (Downloadable) options are disabled.
- The clock for such service render period starts from the point of time at which user opens the first selected document. The pulse rate considered is in Seconds. Addendum for Form 4 & 11 is not part of VPD.
